Horses will be asked to walk/trot or walk/trot/canter on the rail in both directions. ***if more than 6 entries the class may be split into 2 groups; semi-finalists will ride together for final placings OR canter will be ridden in two separate groups.*

Post Entries: Allowed, if time permits. If show is filled, your name will be placed on a waiting list.

No stabling available.

Placings: Tests will be pinned using the Danish system: Blue: 67% or higher, Red: 62%-66.999%, Yellow: 57%-61.999%, White: 52%-56.999%, Pink 47%-51.999%. This method rewards the rider's hard work and individual accomplishments without the stress of head-to-head competition. It also facilitates riders getting their test scores quickly without the class needing to be completed for results. Scores will be reported to TDC for the Year-End Awards program.

ASTM helmets are required at all times while mounted.

Please follow USEF equipment rules. Illegal equipment, including bandages, will not be allowed.

No dogs allowed on the show grounds.

Ride times will be emailed Thursday October 14.
