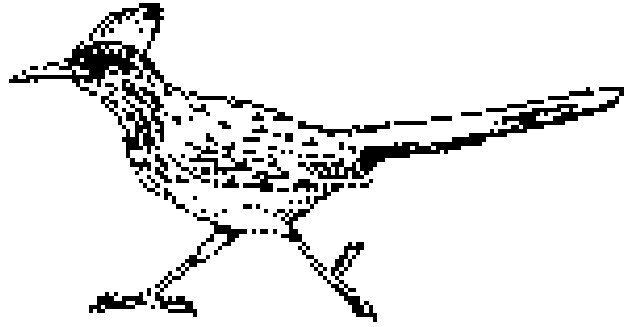

- ▶ If you are showing in the Road Runner II USEF/USDF Dressage Show August 18-19 and you sign up for a show stall (\$110) you do not have to pay a separate stall fee for your horse showing at the Road Runner WDAA Western Dressage Show.
- ▶ If you are showing in the Road Runner II USEF/USDF Dressage show August 18-19 and pay the \$45 office fee for that show, you do not have to pay the \$30 office fee for the WDAA Western Dressage Show. If you enter online, the \$30 fee is automatically added. That \$30 fee will be refunded to you at the show.
- ▶ You still need to complete and submit a separate entry form for the Road Runner WDAA Western Dressage Show.
- ▶ If you are showing only in the Road Runner WDAA Western Dressage Show and coming with other horses that are showing in the Road Runner II USEF/USDF Dressage show, you must have submitted an entry for the WDAA Western Dressage show, paid for a show stall (\$110), and the Western Dressage Show office fee (\$30).

## General Information and Rules of the Show

This WDAA show will be governed by the USEF Western Dressage (WD) Rule Book and must adhere to USEF WD rules for all tests. WDAA recognized shows complies with Safe Sport Sanctions per USEF General Rule 703.

**ENTRIES:** **\*\*Credit Card Entries must use Equestrian Entries. The show itself does not accept credit cards.**

Entries are accepted on a first come, first served basis by on-line entries or mail. Please use the attached entry form for mail-in entries. Photocopied entry forms (both sides) are acceptable. **Each horse and rider combination requires a separate entry form.**

Owner (or agent), trainer, and the rider must sign the entry form (adult signatures only) in the spaces provided and provide addresses, and telephone numbers. If the owner is the trainer, owner must sign in BOTH

the owner and trainer spaces. A trainer is “any adult who has the responsibility for the care, training, custody, or performance of a horse.”

Junior exhibitor’s name, address, and birth date along with the parent’s or guardian’s signature **MUST** appear in the “Minor Permission” area on the entry form for all juniors exhibiting in the show.

Total entry fees, horse/groom/tack stalls and all other applicable fees must accompany each entry by check or money order. Post-dated checks will not be accepted. Entries received without payment will not be processed until payment is received and will be subject to post entry fees if payment is postmarked after the close of entries.

All horses brought onto the grounds must have a completed entry form and be issued a number, even if they are not competing. See Non-Competing Horses below for full specifications.

**ON-LINE ENTRIES:** Visit [Equestrianentries.com](http://Equestrianentries.com) on the opening day of competition. The signature page and other documents should be uploaded in Equestrian Entries and submitted with show entry or e-mailed separately to the show secretary. You can also use this system to fill out show entries and mail a check to the show secretary at no cost.

**CANCELLATION OR SUBSTITUTION OF ENTRIES:** To encourage early entries the management agrees to refund the entry, except the office fee, on any entry withdrawn in writing (e-mail) prior to the closing date. On the closing date and until August 14, (6 days before the show) a refund of entry, except the office fee, will be made for a horse not fit to show provided that written notice and a veterinary certificate are given to the show secretary by August 14. Cancellation of entries after this date, for any reason, forfeits all fees. After the show has commenced no exhibitor may withdraw horse from the show or remove them from the show grounds without the permission of the Show Management.

If the rider is unable to compete due to contracting or being exposed to COVID 19 prior to the closing date, management agrees to refund all fees, except the office fee, upon written notice (e-mail is fine) to the show secretary by midnight August 11, 2023. After the closing date, but before the show starts, riders unable to compete due to COVID 19 will receive a refund of stabling fees. After the show commenced, there is no refund.

**POST ENTRIES:** **Entries for the Road Runner Western Dressage show must be received ON OR BEFORE the Closing Date of AUGUST 11, 2023 to avoid the Post Entry Fee of \$30.00 per horse.** Post entries will only be accepted if there is time available to schedule the ride. **Once the maximum number of rides for the Sunday session is reached, any subsequently received entries will be notified and placed on a waiting list.**

**NON-COMPETING HORSES:** Non-competing horses are allowed on the show grounds under the following conditions: 1) a signed entry form acting as a liability release; 2) payment of either a stall or haul-in fee; 3) payment of the \$30 Office Fee; and 4) a non-competing horse fee of \$25.

**REFUSAL OF ENTRIES:** Show Management reserves the right to refuse, accept conditionally, or to cancel any entries of any exhibitor.

**RETURNED CHECKS:** All returned checks will be assessed a \$65.00 charge. The exhibitor will have 10 days from notice of the returned check to pay the debt.

**FEED & BEDDING:** Feed and bedding is available on the show grounds at competitive prices. **Shavings may be pre-ordered on the Entry Form at \$12.00 per bag and they will be delivered to your stall prior to your arrival.** Additional Shavings may be ordered at the show at \$14.00 per bag delivered to your stall. NO STRAW IS ALLOWED ON THE GROUNDS. Bedding must be purchased from the Fairgrounds.

**STABLING:** Regular horse stalls & tack/grooming stalls are \$55 per day or any part of a day, \$110 for Friday through Sunday. Stalls will be available after 7:00 AM on Friday August 18. The stalls are in the indoor arena building with the swamp coolers and are the vinyl and pipe 10' x 10' temporary stalls with a door. Show management reserves the right to assign stalls in a manner to facilitate the smooth operation of the show. **If you are coming with a group, please provide one name for the entire group on each entry form, so you are stabled together.** Please list special requests on the entry form, show management will try to accommodate them, but there is no guarantee.

**Early arrival on Thursday** has a separate stall fee of \$150 per stall (tack or horse) Thursday through Sunday. A Thursday arrival needs to be designated on the entry form so the Fairgrounds can be notified. The arenas are not available on Thursday.

**SHARPS CONTAINERS:** Trainers, owners, exhibitors, or agents, you are on notice that improper disposal of needles or other sharp disposable instruments will result in fines of \$100 per occurrence. There are red sharps containers for proper disposal in the stabling area.

**AWARDS:** Ribbons -- First through fourth place. At least two daily prize drawings, plus grand prize drawing for free class at a future Road Runner show. Prize drawing tickets are prepared as follows: 1 ticket for each entry; 3 tickets for each perfect entry, and 1 ticket for each first place. Other prizes may be added to the drawing.

**DRESSAGE CLASSES:** The dressage classes will not necessarily run in the order listed. **To accommodate the late closing date, the competitors will be notified of their ride times via e-mail no later than Wednesday August 16.** A time schedule will also be available in the Secretary's office on Friday, August 18.

**ARENAS:** Indoor Arena (Show): indoors; 117' x 250', footing is sand mix over natural base. Ramada arena (warm-Up): open air covered arena; 116' x 200'; footing is sand mix over natural base. Lounging is not allowed in either the show or warm-up arena. The lounging location is an arena on the north side of the barn with a sand mix over a natural base footing.

**SCHOOLING:** Schooling is allowed in the show arena and warm up area after the show arena is built on Friday morning up to 45 minutes prior to the start of the show. Supervised schooling will be allowed in the show arena during the Saturday afternoon siesta break for the Road Runner Dressage II show beginning 1 hour after the last ride of the morning session and up to 1 hour prior to the evening session. This is to accommodate water and drag operations. The number of riders schooling at any one time will be limited for safety reasons.

**JUDGES:** If for any reason the judge fails to attend this show or to perform his/her duties, Show Management reserves the right to substitute a judge for the one who is officially designated in the Prize List.

**LOCATION OF CLASSES:** Show Management reserves the right to change the location of the classes if necessary, run introductory and basic classes in a small arena, and to modify the schedule if entries warrant.

**DOGS:** Pima County and the Southwest Fair Commission require dogs to be on a leash at all times. Loose dogs may be detained by Fairgrounds personnel and owners charged a fine. Owners are also expected to clean-up after dogs; supplies are provided throughout the Fairgrounds.

**PARKING:** Parking for trailers and other vehicles is in designated areas only. Please respect the no parking signs. Show management reserves the right to move a vehicle that is in violation of the no parking zones.

**FARRIER:** A farrier will be on call for the show and the farrier's number will be posted in the Secretary's office, in the stabling area, and placed in the competitor packets.

**VETERINARIAN:** There will be a veterinarian on call. The number for the veterinarian on call will be posted in the Secretary's office, in the stabling area, and placed in the competitor packets. The on-call veterinarian is: Freedom Run Equine Veterinary Service 520-261-8373.

**DIRECTIONS TO PIMA COUNTY FAIRGROUNDS:** Exit I-10 (Exit 275) at Houghton Road. Drive South on Houghton to Brekke Rd. At Brekke Road, turn right (west). Follow the road until you see the Pima County Fairgrounds on the left, turn left into the entrance. Follow the road to the covered arena. The show office is located inside the Indoor Arena on the south side of the building, between the bathrooms.

**INDEMNITY AND NON-RESPONSIBILITY CLAUSE:** All entries are accepted with the understanding that WDAA, Horse Show Management LLC, Southwestern Fair Commission, Pima County and its districts, all employees, agents, and volunteers will not be held responsible for any loss, damage, or injury to any horse or property at the show. Further that anyone signing the entry form assumes all risk for any injury to themselves, other persons, horses, or damage to any property and agrees to indemnify WDAA, Horse Show Management LLC, Southwestern Fair Commission, Pima County and its districts, all personnel, employees, and volunteers against all loss, damages, and liability, including, but not limited to, all legal costs and attorney fees.

**CAMPERS:** The RV park is now open in the summer, and there are a few spaces south of the indoor arena that have power, please reserve your space on your entry form. The new camper fee is \$35 per day. If you arrive after show hours, please check in with Security and indicate you will pay the show.

## WAIVER AND RELEASE OF LIABILITY Assumption of Risk and Indemnity Agreement

In consideration of Horse Show Management, LLC allowing me, the undersigned, to participate in any capacity (including as a rider, handler, lessee, owner, agent, trainer) in the Road Runner Western Dressage Show; I, for myself, and on behalf of my spouse, children, heirs, and next of kin, and any legal and personal representative, executors, administrators, successors, and assigns, agree to and make the following contraction representations:

A. RULES AND REGULATIONS: I agree that I have read, understand, and agree to all applicable rules for a WDAA show, including the USEF Safe Sport Policy and MAAPP as published at [www.usef.org](http://www.usef.org).

B. ACKNOWLEDGEMENT OF RISK. I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with equestrian sport and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any equestrian competition involves risks and dangers including, but not limited to, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets), inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the show organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers.

C. ASSUMPTION OF RISK: I understand that the aforementioned risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the competition, or the negligent acts or omissions of the "Released Parties" defined below. I hereby voluntarily and knowingly assume all risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in the competition. I also agree to be responsible for any injury or damage caused by me, my horse, my employees, or contractors under my direction and control.

D.
